# Alternative School Accountability Challenge – Better Policy and Effective Accountability

There are over 4,000 public schools and programs across the nation that could be considered "alternative" defining schools serving high concentrations of students with the highest risk factors. State accountability systems generally fail to take alternative schools into account, a product of inattention combined with the inherent challenges of measuring such unique schools. A few states have applied performance standards applicable to mainstream schools with predictably negative results and some duck the challenge entirely; a healthy number of states, however, continue to improve their alternative accountability systems with smarter, more customized measures applicable to alternative populations.
